REVOCATION OF THE CLASSIFICATION OF THE SEVERE ELECTRICITY SUPPLY CONSTRAINT AS A NATIONAL DISASTER

The Head of the National Disaster Management Centre, following the termination of the national state of disaster by the Minister of Cooperative Governance and Traditional Affairs, gave notice that the National Disaster Management Centre revoked the classification of the severe electricity supply constraint as a national disaster.

ELECTRICITY REGULATION ACT AMENDMENT BILL, 2022

PUBLICATION OF EXPLANATORY SUMMARY OF THE ELECTRICITY REGULATION ACT AMENDMENT BILL, 2022

The Minister of Mineral Resources and Energy intends to introduce the Electricity Regulation Amendment Bill, 2022 in the National Assembly shortly. The explanatory summary of the Bill was published in accordance with Rule 276(1)(c) of the Rules of the National Assembly. The purpose of the Bill is to amend the Electricity Regulation Act 4 of 2006 in order to –

- strengthen the role of the National Energy Regulator of South Africa;
- to strengthen the provision related to licensed and exempted activities;
- to amend section 34 of the Act in order to clarify the circumstances under which the Minister may make ministerial determinations;
- to provide for the establishment, duties, powers and functions of the Transmission System Operator to the National Transmission Company South Africa SOC Ltd; and to
- provide for an open market platform that will allow for competitive electricity trading.

ELECTRICITY REGULATION ACT 4 OF 2006

DETERMINATION UNDER SECTION 34(1) OF THE ELECTRICITY REGULATION ACT 4 OF 2006

The Minister of Mineral Resources and Energy determined that new generation capacity is needed to be procured to contribute towards energy security, accordingly, 14 771 megawatts should be procured to be generated from Renewable Energy and Energy Storage sources as described below, which is in accordance with the capacity allocated to those energy sources, under the headings "Storage"; "PV" and "Wind", for the years 2024 to 2030, in Table 5 of the Integrated Resource Plan for electricity 2019 – 2030 (published in GN 1360 of 18 October 2019 in GG 42784).

The new generation capacity determined to be necessary shall be generated in accordance with the following MW allocation per technology:

- Solar PV 3940 MW
- Wind 9600 MW; and
- Energy Storage 1231 MW

Electricity produced from the new generation capacity shall be procured through one or more tendering procedures which are fair, equitable, transparent, competitive and cost-effective.

The procurement programmes shall target connection to the Grid for the new generation capacity as soon as reasonably possible in line with the timetable set out in Table 5 of the IRP 2019.

The electricity may only be sold to Eskom Holdings SOC Limited. The procurer will be the Department of Mineral Resources and Energy.
