# NATIONAL REGULATOR FOR COMPULSORY SPECIFICATIONS ACT 5 OF 2008

COMPULSORY SPECIFICATION FOR ENERGY EFFICIENCY AND FUNCTIONAL PERFORMANCE REQUIREMENTS OF GENERAL SERVICE LAMPS

The Minister of Trade, Industry and Competition withdrew the compulsory specification for single-capped fluorescent lamps (VC 9091) and the compulsory specification for incandescent lamps (VC 8043), and replaced them with the compulsory specification for energy efficiency and functional performance requirements of general services lamps. These requirements should be read together with those of the compulsory specification for safety requirements of general service lamps (VC 9110). The compulsory specification for





energy efficiency and functional performance requirements of general services lamps shall be effective as set out in section 9 of the schedule to the said Notice.

COMPULSORY SPECIFICATION FOR SAFETY REQUIREMENTS OF GENERAL SERVICE LAMPS (GSLs) - VC 9110 I

The Minister of Trade, Industry and Competition withdrew the compulsory specification for single-capped fluorescent lamps (VC 9091) and the compulsory specification for incandescent lamps (VC 8043), and replaced them with the compulsory specification for safety requirements of general service lamps as set out in the attached schedule. These requirements should be read together with those of the compulsory specification for energy efficiency and functional performance requirements of general services lamps (VC 9109). The compulsory specification for safety requirements of general service lamps shall be effective twelve (12) months after the publication of this notice.

# MEDICINES AND RELATED SUBSTANCES ACT 101 OF 1965

EXCLUSION OF CERTAIN ALCOHOL-BASED HAND-RUBS FROM THE OPERATION OF SPECIFIED PROVISIONS OF THE MEDICINES AND RELATED SUBSTANCES ACT, 1965

The Minister of Health excluded the medicines listed in the Schedule to the Notice from the operation of sections 14(1) of the Act and regulations 11 and 12 of the General Regulations made in terms of the Act. The Manufacturer, importer or distributor, licensed in terms of section 22C(1)(b) of the Act, of alcohol-based handrubs listed in the Notice, are excluded from regulations 23(1)(c)(ii), 23(1)(c)(iv), and 23(2)(aa) of the General Regulations made in terms of the Act.
