The President determined that the National Environmental Management Laws Amendment Act, 2022, save for sections 11, 35(a), 57, 60, 61(c) 61(j), 61(k), 62, 63, 64,65,66,72,76, 77, 86, 87, and 88, came into operation on the date of publication of the Proclamation in the Gazette. NATIONAL ENVIRONMENTAL MANAGEMENT ACT 107 OF 1998

EXTENSION OF THE COMMENCEMENT DATE OF THE REGULATIONS TO DOMESTICATE THE REQUIREMENTS OF THE ROTTERDAM CONVENTION ON THE PRIOR INFORMED CONSENT PROCEDURE FOR CERTAIN HAZARDOUS CHEMICALS AND PESTICIDES IN INTERNATIONAL TRADE, 2023

The Minister of Forestry, Fisheries and the Environment extended the commencement date of the abovementioned Regulations by substituting Regulation 13(2) of the Regulations with the following sub-regulation: "(2) These Regulations will commence 300 days from the date of publication in the Government Gazette." Published under Government Notice 3505, Government Gazette 48751 of 6 June 2023.

NATIONAL BIODIVERSITY OFFSET GUIDELINE

The Minister of Forestry, Fisheries and the Environment published for implementation, under section 24J of the Act, the National Biodiversity Offset Guideline. Published under Government Notice 3569, Government Gazette 48841 of 23 June 2023.

NATIONAL ENVIRONMENTAL MANAGEMENT: WASTE ACT 59 OF 2008

PACKAGING GUIDELINE: RECYCLABILITY BY DESIGN FOR PACKAGING AND PAPER IN SOUTH AFRICA

The Minister of Forestry, Fisheries and the Environment published the Packaging Guideline: Recyclability by Design for packaging and paper developed under section 6(1)(a) of the Act, for implementation. Die Packaging Guideline covers four categories of packaging material streams namely metals, glass, paper and plastics. The main purpose of this Packaging Guideline is to reduce the volume of packaging ending up in landfill sites by improving product design, increasing quality of production practices and promoting waste prevention. One of the key objectives of this Packaging Guideline is to assist designers in all forms of packaging with a better understanding of the environmental implications of their design decisions, thus promoting good environmental practices without restricting choice.

WATER SERVICES ACT 108 OF 1997

NAME CHANGE OF UMGENI WATER TO UMNGENI-UTHUKELA WATER

The Minister of Water and Sanitation gave notice to change the name of Umgeni Water to uMngeni-uThukela Water, effective 1 July 2023. Th name change incorporates the geographic area of operations of Umgeni Water and the former Mhlathuze Water.

FERTILIZERS, FARM FEEDS, AGRICULTURAL REMEDIES AND STOCK REMEDIES ACT 36 OF 1947

PROHIBITION REGARDING THE USE OF CERTAIN AGRICULTURAL REMEDIES

The Minister of Agriculture, Land Reform and Rural Development intends to prohibit the use of agricultural remedies containing chlorpyrifos and cartap hydrochloride as active ingredients. Interested persons were invited to submit written comments or representations concerning the proposed prohibition within 60 days from the date





of publication of the Notice, to the Registrar: Fertilizers, Farm Feeds, Agricultural Remedies and Stock Remedies Act 36 of 1947, Department of Agriculture, Land Reform and Rural Development.
