NATIONAL ENVIRONMENTAL MANAGEMENT ACT 107 OF 1998

CONSULTATION ON THE INTENTION TO AMEND THE ENVIRONMENTAL IMPACT ASSESSMENT REGULATIONS, LISTING NOTICE 1, LISTING NOTICE 2 AND LISTING NOTICE 3 OF THE ENVIRONMENTAL IMPACT ASSESSMENT REGULATIONS, 2014 FOR ACTIVITIES IDENTIFIED IN TERMS OF SECTION 24(2) AND 24(D) OF THE NATIONAL ENVIRONMENTAL MANAGEMENT ACT, 1998.

The Minister of Forestry, Fisheries and the Environment intends to amend the Environmental Impact Assessment Regulations, Listing Notice 1, Listing Notice 2 and Listing Notice 3 of the Environmental Impact Assessment Regulations, 2014 for activities identified in terms of section 24(2) and 24(d) of the National Environmental Management Act, 1998. Members of the public were invited to submit written comments or inputs, within 30 days after the publication of the Notice in the Gazette, to the Director-General, Department of Forestry, Fisheries and the Environment.

DRAFT NATIONAL APPEAL REGULATIONS, 2023

The Minister of Forestry, Fisheries and the Environment published for public comment the draft regulations pertaining to the processing, consideration of, and decisions on appeal, in terms of section 43, section 44(1)(b) and 47 of the Act. Written comments may be submitted to the Deputy Director-General: Regulatory Compliance and Sector Monitoring, Department of Forestry, Fisheries and the Environment, within 30 calendar days from the date of the publication of the Notice in the Government Gazette or the newspaper, whichever is the later date.
