##### *UPDATE TO THE SCHEDULE 3 LIST OF OCCUPATIONAL DISEASES*

The Minister of Employment and Labour made updates to the list of occupational diseases as appended in Schedule 3 of the Act and the methodology of determining disability. The proposed updated list conforms to the International Labour Organisation's List of Occupational Diseases as revised in 2010. The updated list and the updated methodology of determining disability became effective from the date of publishing the Notice in the Government Gazette.

#### PHARMACY ACT 53 OF 1974

*CRITERIA TO ACCREDIT A GENERIC SHORT COURSE FOR A PHARMACIST WHO WISHES TO APPLY FOR REGISTRATION AS A RESPONSIBLE PHARMACIST.*

The South African Pharmacy Council intends to publish in terms of Section 3(e)(i), Sections 33 and 34 of the Pharmacy Act, 53 of 1974, read together with the Regulations relating to pharmacy education and training the criteria to accredit a generic short course for a pharmacist who wishes to apply for registration as a responsible pharmacist. Interested parties were invited to submit, within 60 days of publication of this notice, substantiated comments on or representation regarding the proposed Guidelines. Comments must be addressed to the Registrar, the South African Pharmacy Council by way of email BN@sapc.za.org (for the attention of the Company Secretary and Legal Services).
