NATIONAL RAILWAY SAFETY REGULATOR ACT 16 OF 2002

NOTIFICATION OF PUBLICATION OF THE DRAFT SAFETY MANAGEMENT DETERMINATION FOR PUBLIC COMMENTS BY ALL INTERESTED AND AFFECTED RAILWAY STAKEHOLDERS

The Acting Chief Executive Officer of the Railway Safety Regulator published the Draft Safety Management Systems Determination for public comments. All interested and affected Stakeholders are invited to submit their written comments within 60 days from the publication of the Draft Safety Management Systems Determination in the Government Gazette, to <u>smsreview@rsr.org.za</u>. PUBLICATION OF THE REGULATOR INTERFACE AGREEMENTS STANDARD FOR IMPLEMENTATION AND COMPLIANCE BY RAILWAY OPERATORS

The Acting Chief Executive Officer of the Railway Safety Regulator published the Interface Agreements Standard for implementation and compliance by the Railway Operators. This Standard applies to all Railway Operators as defined in terms of the Act. The Railway Operators are henceforth required to comply by implementing the requirements which are specified in the Standard.

PUBLICATION OF THE COMMON SAFETY METHOD ON RISK ASSESSMENT AS AN ADDENDUM TO THE EXISTING SAFETY MANAGEMENT SYSTEM DETERMINATION, FOR IMPLEMENTATION AND COMPLIANCE BY RAILWAY OPERATORS

The Acting Chief Executive Officer of the Railway Safety Regulator published the Common Safety Method on Risk Assessment (CSM-RA), as an Addendum to the existing latest version of the Determination in Terms of Section 28 of the National Railway Safety Regulator Act 16 Of 2002, for implementation and compliance by the Railway Operators. This CSM-RA addendum applies to all Railway Operators as defined in terms of the Act. The Railway Operators are henceforth required to comply by implementing the requirements which are specified in this addendum.

DETERMINATION OF SAFETY PERMIT FEES FOR 2024 / 2025 FINANCIAL YEAR

The Minister of transport determined the fees that the Railway Safety Regulator must charge for the safety permits, with effect from 1 April 2024 to 31 March 2025. The fees were published under General Notice 2393, Government Gazette 50391 of 28 March 2024.

COMPENSATION FOR OCCUPATIONAL INJURIES AND DISEASES ACT 130 OF 1993

ANNUAL INCREASE IN MEDICAL TARIFFS FOR MEDICAL SERVICES PROVIDERS

The Minister of Employment and Labour prescribed the scale of fees for Medical Aid payable under section 76, with effect from 1 April 2024. Medical Tariffs increase for 2024/2025 are as follows:

- 1. Hospital Tariffs: to be increased between 0 % and 9.7 % as applicable.
- 2. Non-Hospital Tariffs: 5.4 %





The fees are applicable in respect of services rendered from 1 April 2024 for the financial year 2024/25 and exclude 15 % VAT.
