NATIONAL ENVIRONMENTAL MANAGEMENT ACT 107 OF 1998

EXTENSION OF THE COMMENCEMENT DATE OF THE REGULATIONS TO DOMESTICATE THE REQUIREMENTS OF THE ROTTERDAM CONVENTION ON THE PRIOR INFORMED CONSENT PROCEDURE FOR CERTAIN HAZARDOUS CHEMICALS AND PESTICIDES IN INTERNATIONAL TRADE

The Minister of Forestry, Fisheries and the Environment extended the commencement date of the Regulations to domesticate the requirements of the Rotterdam Convention on the prior informed consent procedure for certain hazardous chemicals and pesticides in the international trade, 2023. The Regulations will commence 660 days from the date of publication in the Government Gazette, which was 17 February 2023.
