NATIONAL ENVIRONMENTAL MANAGEMENT: INTEGRATED COASTAL MANAGEMENT ACT 24 OF 2008

EXTENSION OF PUBLIC DOMMENTING PERIOD FOR THE DRAFT REGULATIONS FOR THE ENVIRONMENTAL MANAGEMENT OF OFFSHORE BUNKERING

The Minister of Forestry, Fisheries and the Environment published the Draft Regulations for the environmental management of offshore bunkering for public comment in Government Notice No. 5886, Government Gazette No. 52151 of 21 February 2025 (Draft Regulations). The public commenting period for the submission of written comments on the Draft Regulations is extended to 5 May 2025.

AGRICULTURAL PESTS ACT 36 OF 1983

NATIONAL WATER ACT 36 OF 1998

REVISION OF THE PRICING STRATEGY FOR RAW WATER USE CHARGES IN TERMS OF SECTION 56(1) OF THE NATIONAL WATER ACT, 1998

The Minister of Water and Sanitation issued an Erratum Notice to the published Revised Pricing strategy for Raw water Use Charges dated 21 June 2024, in respect of Notice 4992 of 2024, i Government Gazette 50852. The purpose of the erratum is to rename the "Resource Poor Farmer/Forester Subsidy" to "Resource Poor farmer/Forester Charges Waiver" in the revised Pricing Strategy for Raw Water Use Charges. The amendment is necessitated by the need to clarify that the provisions of the Resource Poor farmer/Forester Policy established in terms of regulations set under Section 62 of the Act are in the form of a waiver of charges to eligible farmers and tree growers instead of monetary assistance as may be construed from the term "subsidy"
