AMENDMENTS TO THE REGULATIONS TO PHASE-OUT THE USE, PRODUCTION, DISTRIBUTION, SALE, IMPORT AND EXPORT OF PERSISTENT ORGANIC POLLUTANTS

The Minister of Forestry, Fisheries and the Environment amended the Regulations to phase out the use, production, distribution, sale, import and export persistent organic pollutants, 2019.
