##### **NATIONAL ENVIRONMENTAL MANAGEMENT ACT 107 OF 1998**

*CONSULTATION ON THE INTENTION TO ADOPT A SUBSTATION EXCLUSION NORM AND TO EXCLUDE THE DEVELOPMENT AND EXPANSION OF TRANSMISSION AND DISTRIBUTION SUBSTATIONS FROM THE REQUIREMENT TO OBTAIN AN ENVIRONMENTAL AUTHORISATION*

The Minister of Forestry, Fisheries and the Environment intends to adopt the norm for *exclusion of Identified Activities Associated with the Development and Expansion of transmission and Distribution Substations in Areas of Low and Medium Environmental Sensitivity*, and to exclude activities identified in terms of section 24(2)(a) and (b) of the Act, associated with the development and expansion of transmission and distribution substations, from the requirement to obtain environmental authorisation, based on compliance with the Norm as set out in the said Notice.
