These Regulations will repeal the Environmental Regulations for Workplaces, 1987.

REGULATIONS RELATING TO THE SURVEILLANCE AND THE CONTROL OF NOTIFIABLE MEDICAL CONDITIONS: AMENDMENT

### PHARMACY ACT 53 OF 1974

SOUTH AFRICAN PHARMACY COUNCIL RULES RELATING TO THE SERVICES FOR WHICH A PHARMACIST MAY LEVY A FEE AND GUIDELINES FOR LEVYING SUCH A FEE OR FEES

The South African Pharmacy Council published for implementation, *Rules relating to the services for which a pharmacist may levy a fee and guidelines for levying such fee or fees*, in terms of sections 35A (b)(iii) and 49(4) of the Pharmacy Act 53 of 1974. These Rules shall replace the existing Rules under Board Notice 193 of 2010, w.e.f 1 January 2025. These rules must be read in conjunction with the *Rules relating to Good Pharmacy Practice* (GPP) as published by the South African Pharmacy Council.

#### **HEALTH PROFESSIONS ACT 56 OF 1974**

### COMPENSATION FOR OCCUPATIONAL INJURIES AND DISEASES ACT 130 OF 1993

ANNUAL INCREASE IN MONTHLY TARIFFS FOR MEDICAL SERVICES PROVIDERS

The Minister of Employment and Labour prescribed the scale of Fees for Medical Aid, w.e.f. 1 April 2025. Medical Tariffs will increase by 6 % for the financial year 2025/2026. The fees are applicable in respect of services rendered from 1 April 2025 and exclude 15 % VAT.
