The Minister of Health intends to amend Regulation 12 relating to the Patient Information Leaflet". Interested persons are invited to submit any substantiated comments or representations on the proposed regulations to the Director-General: Public Entities Governance, Department of Health, within three months of publication of the Notice.

EXCLUSION OF MEDICINES FROM THE APPLICATION OF CERTAIN PROVISIONS OF REGULATION 12 OF THE GENERAL REGULATIONS MADE IN TERMS OF THE MEDICINES AND RELATED SUBSTANCES ACT 101 OF 1965

The Minister of Health excluded medicines from the application of certain provisions of Regulation 12(2) of the General Regulations, in that all medicines are excluded with respect only to the requirement that the patient information leaflet required in terms of Regulation 12(1), also be in one other official language in addition to English.
